From above table, all models have same electrical parameters. They difference just in CCT. 6500K is the worse case, which could cover other CCT. Unless otherwise specified, the P2835W6H6-C04-8D1A01 was chosen as the representative models to perform the test.

#### **Remarks:**

The measured LED, part number P2835W6H6-C04-8D1A01, with ANSI bin 6500K, is part of the Hongli LED Package product family. The present classification is thus valid(worst case) for all Hongli LED Package P2835WxH6-C04-8D1A01 from ANSI bins equal to 6500K or lower CCT.


